Message from the Advocacy Committee

What is advocacy? How many of us are old enough to remember: "Won't you please be a booster For Wayne and Shuster".... Every week, Johnny Wayne and Frank Shuster urged their viewers to become cheerleaders for their comedy show. According to one definition I found on-line, they were asking people to indulge in a bit of advocacy for them. Depending on the situation, advocacy can be seen primarily as political advocacy: trying to get elected officials to act to your benefit. By other definitions, it's "arguing in favour of something, such as a cause, idea or policy." In fact, almost anything that raises awareness of something could qualify. In a sense, it blends seamlessly with public relations, promotion, even marketing in its broadest sense.

Wouldn't it be great to find stories about our museums in the newspapers at least once a week? To see our stories on TV or hear them on the radio more often? Wouldn't it be super if everybody in our communities understood and appreciated what we're doing, particularly because we're doing those things to improve those communities? I'm sure we'd all like to see our politicians taking more interest in New Brunswick's museums. The fact that they don't may well be our fault. How many of us have taken the trouble to speak to them about what we do and about the things that concern us?

Advocacy is one of the functions of AMNB. But, to do that job properly, we have to be sure that we know what concerns our membership. We can approach government on your behalf, but only if we're told what to discuss. Advocacy doesn't just mean trying to influence government. It can also mean influencing the public. We live in a democracy, where the concerns of people become the concerns of leaders.

On behalf of the AMNB Advocacy Committee, Brian Clark, Jeanne-Mance Cormier and me, I'm asking you all to let us know what worries you, what you want brought to the attention of government. I'm also suggesting that you take every opportunity to speak to your municipal leaders and to gain the support of the public. We can all be boosters for museums. Every voice counts.

York Sunbury Historical Society: 2011 Martha J. Harvey Awards




On December 6, 2011, the York Sunbury Historical Society honoured this year's recipients of the 2011 Martha J. Harvey Awards of Distinction: Bob Dallison and George Bidlake.

The annual awards honour outstanding contribution to the field of history in central New Brunswick. Award winners, chosen from nominations from YSHS members, were recognized at the Society Christmas luncheon in Fredericton.

The award recipients were selected based on their commitment to central New Brunswick's history. The awards were presented to Bob Dallison for his research in New Brunswick's military history, publications and his continuous support for the Society and Fredericton Region Museum. The second award was presented to retired teacher George Bidlake for bringing history alive for his students, his research of various Fredericton groups and landmarks, as well as his publications.

Faye Pearson Retires After 19 Years Service

This November, Faye Pearson retired as Director of the Kings County Museum in Hampton. For over nineteen years, Faye was the energetic force behind the Museum. With great wit and tireless enthusiasm, Faye greeted visitors, trained student staff, conducted genealogy research, conserved artifacts, and created exhibits. Her most important contribution, however, is raising awareness of the Kings County Museum and the Historical & Archival Society throughout the province and Canada.



Faye joined the Museum in 1992 seeking a new challenge and wanting to pursue her interests in genealogy research. Little did she know that this new 'project' would turn into a 19 year career! By her second meeting, Faye became the Society's Secretary. Soon after, she began working on traveling exhibits for community events. Faye was hooked. She stepped in as Director in September of 1995 and has been a fixture ever since.

Those who know Faye will be surprised to learn how worried she was about the role initially: "I was excited, but so nervous about how to do it, who to ask for guidance. I ended up coming to the museum five days a week at first. I felt I had to know every artifact, where everything was if I was to do a good job." Her desire to make the museum a success led Faye to take a series of courses in museum management and artifact preservation. She attained a Level 2 Certificate in Museum studies and armed with her new knowledge and contacts, worked

diligently to raise the profile of Kings County heritage throughout the province and Canada.

Among Faye's successes was the introduction of the Virtual Collections system at the Museum. Faye coordinated funding and oversaw the introduction of the Virtual Collections system to manage the museum's nearly 15,000 artifacts. It's a project that took a great deal of time and effort over many years, but Faye recognized its value to preserving Kings County heritage. Virtual Collections is undoubtedly a huge part of the legacy that Faye Pearson leaves the Museum. At the Kings County Historical & Archival Society AGM in November, Faye was honoured for her tireless dedication, her enthusiasm, and her vision. Through her outstanding service, another great chapter has been written in Kings County history. Best of luck to you, Faye, from all of your friends at the AMNB!

Jessica Ryan named to the Order of New Brunswick

On October 27th, Jessica Ryan was invested in the Order of New Brunswick at a ceremony held at Government House in Fredericton. The award honours "current or former long-time residents of New Brunswick who have demonstrated a high level of individual excellence and achievement in any field, having made outstanding contributions to the social, cultural or economic well-being of New Brunswick and its residents."

For decades, Jessica Ryan has worked tirelessly to preserve Bathurst's heritage and history. Before a local museum existed, Jessica used her home and garage as the repository for treasured heritage items that she collected—part of her effort to preserve Bathurst's historic past. In 2003, her love of heritage artifacts culminated in the creation of the Nepisiguit Centennial Museum/Cultural Centre, where the public now enjoys the artifacts she has collected and preserved. Jessica continues to volunteer hundreds of hours at the museum, sharing her knowledge and enthusiasm for the past with all who visit.

Jessica Ryan's involvement in heritage preservation also led her to become involved in another, provincial, project; she participated in the advisory committee that oversaw the restoration of Old Government House in Fredericton.

Congratulations to you, Jessica, on receiving the Order of New Brunswick, and thank you for your devotion to preserving the heritage of the Chaleur Region, and New Brunswick.
